This AIRCRAFT RENTAL AGREEMENT ("Agreement") is made this _____ day of _____, 20____ by and between Mother Lode Flying Club (hereinafter "the club") whose address is Calaveras Airport, 3600 Carol Kennedy Dr, San Andreas, CA 95249

and ("Pilot") _____ whose address is reflected on the first page of this agreement.

Renter hereby expressly acknowledges and binds Renter, Renter's heirs, and assigns for all liabilities to pay the club the following:

- a. Service and time charge computed at the applicable rate as specified at the time of rental
- b. A sum equal to the cost of all damages to the aircraft, or loss of equipment of the aircraft during the rental period as well as any damages to their persons or property caused in whole or in part by failure to comply with the rules and regulations of the FAA, the terms of this agreement, the procedures outlined in the club rules, the procedures outlined in the Aeronautical Information Manual, or by the negligence of Renter.

Payments: Payment is due when services are rendered. All past due accounts will incur a finance charge in the amount of 1.5% of the balance due per month. All checks returned for "Insufficient Funds" will incur a service charge in the amount of \$40.00 per check in addition to the cost of services rendered and any charges by their bank.
